NOTE: The list indicated in Annexure 'A' is **NOT AS PER MERIT.**

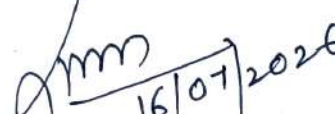

The functional classification of PwBD candidate(s) as prescribed in Railway Board's letter No.E(GP) 2022/2/20 dtd.14.11.2022 may also be indicated in the communication.
- DAR/Vigilance clearance indicating whether the candidate is undergoing punishment in DAR/Vigilance case affecting his promotion or otherwise.
- Service Record duly completed in all respect (Xerox copy duly attested).
- Bio-data form enclosed as Annexure 'B' duly filled by the candidates and countersigned by Personnel officer.
- Original/attested copy of confidential report folder (APARs) of the above employees for the year ending from March 2021 to March 2025 (5 years). In case, any of the APARs is not written or not available, a certificate to this effect along with the APAR(s) for the preceding year(s) may be sent.
